# Year-End

## HIGHLIGHTS

Using a 2012 donor gift, GCU launched global transformation initiatives to offer real and virtual opportunities that deepen intercultural understanding and create a sense of community across borders. For example, in May, five **GCU students were awarded \$10,000 scholarships to participate in an International Ambassadors Program, offered in conjunction with Villanova University and the American University of Rome.**

**More than 50 students from Lakewood participated in the 2012 Girls in Science and Technology (GIST) program** as GCU faculty led a week of activities in chemistry, biology, forensics, physics, aeronautics, sustainability, geometry, math, and statistical analysis.

The annual **GCU Scholarship Classic**, played this year at Eagle Oaks Golf and Country Club, raised more than \$140,000 at the April 22 event where New Jersey Natural Gas, represented by CEO Laurence M. Downes, was honored. Overall, the GCU Advancement team raised \$1,452,829, and \$658,408 in grants and foundation funds.

**Washington Monthly** ranked Georgian Court 133<sup>rd</sup> among 684 master's-level universities nationwide. In their "Best Bang for the Buck" category, GCU was 63<sup>rd</sup> among 152 schools. The magazine evaluates schools "based on their contribution to the public good in three broad categories, including social mobility, research, and service."

**The Year of Faith: A Call to Holiness at Georgian Court University** launched with a \$50,000 grant from the Council of Independent Colleges Network for Vocation in Undergraduate Education (NetVUE) program. The Year of Faith, which included a public lecture by Bishop David M. O'Connell of the

Diocese of Trenton, promoted related campus activities, ministry events, guest lectures, book discussions, and community outreach.

GCU made the 2013 President's Community Service Honor Roll. The national award reflects the 6,490 hours GCU students donated to causes such as the Children's Miracle Network, Make-A-Wish Foundation, Tuberous Sclerosis Foundation, Twin Oaks, Lace Up 4 Pediatric Cancer, and the Ocean County Crop Walk.

GCU joined *Cooking with Nonna*, the popular online resource and cooking show that features authentic Italian cuisine and culture, to encourage healthy eating and celebrate the importance of family. Faculty and graduate students from GCU's holistic health studies program provided additional health and nutrition content for the site where host Rossella Rago focuses on Italian cooking and the influence of Italian grandmothers, or *nonne*.

GCU's transition to coeducational status and the recruitment of male athletes continued to draw media interest from outlets such as the *Star-Ledger*, *National Catholic Reporter*, *Inside Higher Education*, *The Monitor of Trenton*, and the *Wall Street Journal*.

GCU completed its second solar panel installation on top of the Arts and Science Center, reducing electricity costs, and was honored with the **Grassroots Environmental Activist Award** by the New Jersey Environmental Federation.

**Lakewood Together**, the partnership between Georgian Court and the Lakewood Public Schools, paired mentors from the School of Education with classroom teachers and contributed to the enormous success

of the Lakewood Parent Academy to strengthen parental involvement in the schools.

In the U.S. Department of Education's most recent test to gauge whether schools are financially responsible enough for their students to receive federal aid, GCU scored a 3 on a scale of 1 to 3, with 3 being the healthiest rating.

GCU's counseling psychology programs were endorsed by the **Council for Accreditation of Counseling & Related Educational Programs (CACREP)**.

The GCU School of Business earned re-accreditation by the **Accreditation Council for Business Schools and Programs (ACBSP)**.

TD Bank awarded GCU a \$15,000 grant for "**Court Connections: Preparing Students for Career Success**." The program builds on the services of GCU's Office of Career Development by providing advanced career technology, new career and personality type assessment software, career coach presentations, personal branding workshops, and more.

The GCU-Meridian Health School of Nursing's Bachelor of Science in Nursing (B.S.N.) degree program was accredited by the **Commission on Collegiate Nursing Education (CCNE)**.

GCU's applied behavior analysis programs received approval from the **Behavior Analyst Certification Board (BACB)**.

Five Women in Leadership Development (WILD) participants were sponsored by the American Association of University Women to participate in the **National Conference for Women Student Leaders**.

**GCU was the 2013 East Coast Conference Outdoor Track & Field Champion.** Three students—Tiffany Okieme '18, Alyssa Hudgins '13, and Chanel Rogers '17—competed at the NCAA Division II Outdoor Track & Field Championships, where Tiffany finished second nationally in shotput and was an alternate for Team USA at the Pan-American Junior Championships. Alyssa was named 2013 ECC Outdoor Co-Athlete of the Year, and both Tiffany and Alyssa earned All-American status.

Lacrosse player Olivia Rotunno '13 was an **NCAA Woman of the Year** nominee.

GCU students, faculty, staff, and alumni formed GCU Cares to assist others in the aftermath of Superstorm Sandy. Students performed cleanups, volunteered at residential and commercial sites and organized clothing and food drives. Alumni and friends donated nearly \$40,000 to underwrite temporary campus housing for local students who were displaced. Donations also funded textbooks, lab materials, and laptops for those whose families lost everything.

New Jersey voters approved the higher education bond program, a state-backed \$750-million matching fund program to help university and colleges pay for academic construction and renovation projects. As part of the program, GCU's

winning \$8.4 million proposal will fund upgrades and renovations to Raymond Hall, Hamilton Hall, and the Arts and Science Center.

GCU partnered with outside firm Cognitive Marketing to complete a branding study, update the university's brand identity, and develop a comprehensive advertising and marketing strategy, implemented via traditional, social, and digital media.

GCU was the exclusive higher education sponsor for the PNC Bank Arts Center's summer concert series, giving the university valuable exposure during performances by such artists as Kelly Clarkson, Dave Matthews Band, Rascal Flatts, and others. ↗

## *Putting the year in perspective* F Y 1 3 F I S C A L N O T E

GCU's financial performance last year was a bit miraculous after starting with two strikes against it. First, the fall enrollment of first-time, first-year students was much below what was anticipated; and then, Hurricane Sandy and Nor'easter Athena closed the university for 10 days in October and November. Faced with the loss revenues of the first and the cost of the second, ending the year with the total net assets increasing by over \$4 million was miraculous. Add to this the university's \$722,000 investment in its co-ed transformation and an additional \$458,000 infusion into marketing, and the results are even more miraculous. Though we did incur a loss from unrestricted operations of just under \$1 million, that was against an anticipated (budgeted) loss of \$3 million. The increase in net assets was largely the result of exceptional investment portfolio results, but the lower-than-expected operating loss reflected strong enrollment activity in the spring semester and our commitment to keeping expenditures in check. Of course, the university needs to turn that operating loss around; we expect that to happen in another year. Keeping it all in perspective, it is noteworthy that we were able to weather the shocks and move forward.




