You will be notified by the Office of Financial Aid if you are academically qualified for the grant. If you are qualified and choose to participate in the TEACH Grant program, you will be required to file an **Agreement to Serve** annually with the U.S. Department of Education and participate in a counseling session with the Office of Financial Aid.
