U.S. Department of Education Regulations for Those Licensure and Certification Programs with Title IV HEA Funding June 18, 2024 (date state information posted below was gathered and compiled)

As of July 1, 2024, the U.S. Department of Education requires all licensure and certification programs to post on their website new disclosure information to replace what was previously mandated to be disclosed as of July 1, 2020. The 2024 requirements are for these programs to post on their website:

- 1. A list of all states/jurisdictions where the institution's curriculum meets state educational requirements for professional licensure or certification.
- 2. A list of all states/jurisdictions where the institution's curriculum does not meet state educational requirements for professional licensure or certification.

If GCU was unable to determine whether or not a curriculum meets educational requirements in a jurisdiction, GCU has shown the program as "determination not made". Readers should treat "determination not made" the same as "does not meet" when making decisions about whether or not to enroll in a program, unless they are able to determine for themselves that the program meets educational requirements for licensure or certification. All information in the table below is subject to change.
